After submitting your qualified, completed application, you should receive your rebate check within six weeks. Please make sure to fill out all the information, as incomplete applications may cause delays.

### REBATE REQUIREMENTS

- ✓ Thermostat must be installed in an existing home that uses CenterPoint Energy natural gas or electric as the primary heat source. Dual-fuel homes do not qualify.
- ✓ Thermostat must be new and installed between January 1, 2023 and December 31, 2023. Limit of two per home (includes both “Wi-Fi” and “Smart”).
- ✓ **“Smart” thermostat:** Must be Wi-Fi capable, connected to the home, and ENERGY STAR® certified as “Smart.”
- ✓ **Wi-Fi enabled thermostat:** Must be Wi-Fi capable and connected to the internet without the use of an additional device.
